Principal's Message

Dear Parents/Guardians,

Over the past several weeks the issue of social media usage by 9-11 year olds has become an area of focus at Johnson School. It is therefore, that this week the fourth and fifth grades attended grade level assemblies focused on *Internet Safety*.

Together with our School Resource Officer, I discussed the importance of responsible use and safety. I shared with students that social media usage by fourth and fifth graders is <u>not appropriate</u>. Most, if not all, social media sites and apps require students to be 13 years of age to sign up. I emphasized sites such as Facebook, Instagram, Snapchat, Vine, and Whisper are **not** suitable for children at this age.

Additionally, SRO Whaley and I shared sites such as Youtube and Minecraft which are popular among our students, are especially concerning as they offer an opportunity to chat with strangers and potential predators. Officer Whaley identified the importance of not sharing their location or identity online. She went on to say, students should not enter into conversations online with individuals they do not know. Students were told texting, iChat, and iMessaging leaves a digital footprint-nothing that is put on the Internet ever goes away, even if it is deleted.

Please take this opportunity to ask your child about the assembly. I appreciate your continued support as we join together in a commitment to keep our children safe. Many children don't realize the consequences that come with social media. They underestimate how easily accessible their information is, and can forget that others are watching their online activity.
